FEES

ARBITRATION/ MEDIATION/ FACT FINDING

\$750 Per Diem or Federal. or State Agency (if lower). Per Diem Rate includes hearing, research, writing and travel time. Partial days are prorated.

\$900 Per Diem for Expedited Hearings when a written award is not desired

MEDIATION & FACT FINDING

\$750 Per Diem or State or Federal Agency Rate if lower. Less than full days are prorated as above

DOCKETING FEE

No docketing fee

CANCELLATION FEE

\$750 for each day of scheduled hearing when cancelled within 30 days of the hearing date. Notice of cancellation must be received not less than 30 days prior to the hearing date

TRAVEL TIME

Travel is usually scheduled on the date of the hearing. 3 hours each way is included in the per diem rate. Maximum time per day is 10 hours and includes travel and hearing times. Excess times will be prorated at \$35 per hour

TRAVEL EXPENSES

Automobile Travel is charged at \$.65 per mile and is computed on the lesser distance between the Arbitrator's primary or secondary addresses and the place of hearing;

Meals & Lodging: Incurred only on multiple hearing dates or if necessary to assure timely attendance at a scheduled hearing. Meals and lodging expenses are charged at actual costs;

Air Travel: Only when necessary or when automobile use is impractical
